  - Allow to transform and produce with materials that do not come from areas of conflict, or from proceeds of illegal activity or from sources that do not respect human rights.
  - Allow to produce in respect for the environment and communities involved in the industrial processes of the entire transformation chain.
  - Allow to promote the rights and dignity of workers and those who interact with the company.

As part of this corporate policy, BERKEM Srl undertakes to respect transparency, reliability and legality and also to select commercial and industrial partners who can fully guarantee respect for human rights and the rights of the child in accordance with United Nations resolutions and who can guarantee the acquisition of precious metals from legitimate sources, not involved in the financing of conflicts, terrorist actions or are proceeds of money laundering. Furthermore, always in accordance with the above policy, BERKEM Srl is a Member of the Responsible Jewellery Council (RJC).
